OUR PROGRAMS

FOSTER CARE

Our Foster Care Program offers safety and loving care for children aged newborn to six years old who are at risk for abuse and neglect. Children receive care in trauma-informed, loving homes where we address their basic needs including healthcare. Individualized plans are followed to help them reach appropriate developmental milestones and heal from the effects of trauma and neglect.

FAMILY SUPPORT

Parents receive personalized case management while their children are in our Foster Care program and after reunification. Our case managers develop tailored plans with referrals for substance abuse treatment, housing, employment, and parenting skills. Reunified families continue receiving support through our Aftercare Program, including access to essential resources like our food pantry, diaper bank, and children's clothing closet.

POST-PERMANENCY

Support is offered to families who have opened their hearts to children in need through adoption or permanent conservatorship. Because early neglect and trauma have lifelong effects, we provide resources to help families navigate their child's unique needs. Casa de Esperanza's Post-Permanency Program remains available for as long as support is needed.

VOLUNTEERS

Volunteers for Casa de Esperanza go above and beyond to support our mission. From volunteer foster parents who open their hearts and homes to children in crisis, to weekly volunteers who spend time with our children or help in the office, to our group volunteers who host playdates, keep our food pantry stocked, and make our grounds beautiful, to our event and leadership volunteers - we would not be successful without you!

Adapting to a New Child Welfare Landscape

The need to protect our children and strengthen our families is both urgent and ongoing, and Casa de Esperanza is committed to exploring additional, innovative ways to serve our at-risk families.

The entire structure of child welfare in Texas is changing. Both public agencies, like the Department of Family and Protective Services, and private organizations, such as Casa de Esperanza and other advocacy groups, are continuously working toward a day when child abuse and neglect are eradicated.

What is Texas Child-Centered Care?

- Comprehensive transformation of the Texas foster care system
- Designed to improve outcomes for children and youth in care
- Replaces current system of care
 - Utilizes a universal child assessment tool
 - Placement based on child needs



Casa de Esperanza's mission is to break the cycle of child abuse and neglect, and we do that by providing safe foster care for children and family strengthening services for parents. While our mission has not changed, we have responded to the changes around us in the child welfare system in several ways, including doubling down on outreach efforts to community organizations who serve the same population to better ensure we can reach the vulnerable children and families who need us. The need to protect our children and strengthen our families is both urgent and ongoing, and Casa de Esperanza is committed to exploring additional, innovative ways to serve our at-risk families. 100% of children made progress toward meeting developmental milestones 92% of children remained reunified with family 6 months after discharge

37 Caregivers and 10 Volunteer Community Foster Parents provided care

Children were taken for 245 medical visits, including regular checkups, dental care, and specialists

FOSTER CARE PROGRAM Success Story


Elisa was scared and quiet upon arrival, not wanting to talk or interact with anybody in the house. However, our caregivers focused on building up trust week by week, working to make her feel safe and comfortable. She grew to become very loving towards the other children and caregivers in the house. At dinner time, one of her favorite things to do was go around the table and ask everyone how they felt and how their day had been. We are so glad we had the opportunity to help her grow in trust before she was reunited with her parents.

Cultivating Hope

Sarah didn't have consistent parenting when she was a girl. She missed out on learning many life skills that would have been helpful when raising her own children. When Sarah and her kids were reunited after 7 months apart, her kids talked about how much they enjoyed and missed the meals at Casa. Sarah asked her Casa case manager for help learning to cook dinners. Her case manager helped Sarah find recipes, plan a grocery list within her budget, and went over to the apartment to help Sarah with the basics of making a meal. This gave Sarah so much confidence and we are excited to see her grow as a mom!

POST-PERMANENCY PROGRAM

78 families with 127 adults and 120 children received services

13 families received educational and developmental assistance

6 post-secondary students received support through the Casa Scholarship Program



Mia's journey with Casa de Esperanza began as a foster baby in Richard and Dana's home, where she quickly became part of their family. With Casa's support, they navigated the challenges of foster care and fulfilled their dream of adoption, giving Mia the loving, permanent home she deserved. Now, as she prepares to graduate high school and attend Texas State University, Richard and Dana reflect on the unconditional love that changed all of their lives. Their story is a testament to the lasting impact of postpermanency support—ensuring that children like Mia continue to thrive long after leaving foster care.






